Personal data provided to the Commissioner of Customs and Excise (hereinafter referred to as "CCE") pursuant to the requirements of the Anti-Money Laundering and Counter-Terrorist Financing Ordinance, Chapter 615, Laws of Hong Kong (hereinafter referred to as "the AMLO") will be used by CCE for administering the AMLO and enforcing relevant provisions of the AMLO;

The report must be given as soon as practicable and in any event before the earlier of the following—(i) the expiry of one day after the transaction; (ii) the earliest time when a specified individual@ leaves Hong Kong.

 - (ii) does not have a place of business in Hong Kong; and
 - the total number of days on which the person's precious metals and stones business is carried on in Hong Kong does not exceed 60 (b) days in a calendar year.
