## 收集個人資料聲明 Personal Information Collection Statement

### 1. 收集目的 Purpose of Collection

- 1.1 依據香港法例第615章《打擊洗錢及恐怖分子資金籌集條例》(下稱「《打擊洗錢條例》」)的規定向海關關長(下稱「關長」)提供的個人資料，關長會作為實施《打擊洗錢條例》及執行《打擊洗錢條例》的有關條文之用；  
Personal data provided to the Commissioner of Customs and Excise (hereinafter referred to as “CCE”) pursuant to the requirements of the Anti-Money Laundering and Counter-Terrorist Financing Ordinance, Chapter 615, Laws of Hong Kong (hereinafter referred to as “the AMLO”) will be used by CCE for administering the AMLO and enforcing relevant provisions of the AMLO;
- 1.2 提供個人資料屬《打擊洗錢條例》的規定，如未能提供所須的個人資料，貴金屬及寶石交易商監理科將無法處理有關申請。  
Provision of the required personal data to CCE is obligatory for compliance with the AMLO. The Dealers in Precious Metals and Stones Supervision Bureau will not be able to process the relevant application if the required personal data are not provided.

### 2. 資料轉介 Classes of Transferees

你在此申請表填報的個人資料，可能會向其他政府部門/政策局或機構披露，以履行上文所載的目的；或根據《打擊洗錢條例》的第76D條向任何第三者披露；或在法律授權或規定的情況下須作出此等披露。  
The personal data you provide in this application form may be disclosed to other Government departments/bureaux or organizations for the purposes mentioned above; or any third parties under section 76D of the AMLO; or where such disclosure is authorized or required by law.

### 3. 查閱個人資料 Access to Personal Data

根據香港法例第486章《個人資料(私隱)條例》(下稱「《私隱條例》」)的規定，你有權查閱及更正你的個人資料。查閱的權利包括有權索取此申請表內填報的個人資料的複本。根據《私隱條例》的規定，香港海關有權收取合理費用，以處理任何查閱資料要求。  
You have the right of access to and correction of your personal data as provided for in the Personal Data (Privacy) Ordinance, Chapter 486, Laws of Hong Kong (hereinafter referred to as “the PDPO”). Your right of access includes the right to obtain a copy of your personal data provided in this application form. In accordance with the provisions of the PDPO, Customs and Excise Department has the right to charge a reasonable fee for the processing of any data access request.
